CUSTOMER PURCHASE AGREEMENT

I/ We of whose address is hereby agree to purchase all LPGas requirements from Fiji Gas Ltd and/or from their Authorized Agents.

Fiji Gas cylinders remain the property of Fiji Gas. Fiji Gas Ltd therefore agrees to supply and maintain its cylinders at its expense for as long as this agreement remains in force.

Cylinder

Cost of a new issue is based on a usage fee payable in advance and in addition to the selling price of gas at the time of purchase, as follows:

- 1. 1 x 4.5kg cylinder - usage fee of \$69.00 VIP + current selling price of a 4.5kg gas refill
- 2. 1 x 12kg cylinder - usage fee of \$69.00 VIP + current selling price of a 12kg gas refill
- 3. 1 x 50kg cylinder - usage fee of \$207.00 VIP + current selling price of a 50kg gas refill

Refunds:

Full refunds of the usage fee will be applicable to 4.5kg, 12kg and 50kg cylinders returned within 12 months from the date of first issue purchase. . Customers must retain their receipt of first issue in order for these amounts to be applicable when returning any of the following:

- a) 1 x 4.5kg cylinder – refundable usage fee of \$69.00 VIP
- b) 1 x 12kg cylinder - refundable usage fee of \$69.00 VIP
- c) 1 x 50kg cylinder - refundable usage fee of \$207.00 VIP

The following refund amounts on 4.5kg, 12kg and 50kg cylinders will be effective as of 01st July 2014 for returns more than 12 months from the date of purchase of first issue.

- 1. 1 x 4.5kg cylinder return - \$20.00 refundable
- 2. 1 x 12kg cylinder return - \$20.00 refundable
- 3. 1 x 50kg cylinder return - \$120.00 refundable

Should you choose to have your cylinder delivered, the company cannot guarantee a same day delivery service. Deliveries are dependent on the specified location for delivery and routes of our delivery fleet.

This agreement terminates and supersedes any prior Gas Purchase Agreements by and between the parties. This agreement shall remain in force for an initial period of two (2) years after which it will automatically be extended for a further period of one (1) year unless and/or until a Notice of Termination is issued by either party 90 days prior to the expiry of the agreement, which shall state

- a) the termination of the initial period and
- b) the termination of each annual extension.
